Promotion of Inspectors of Police to the rank of D.S.P. for the year,

2013.

In order to fill up the promotional vacancies in the rank of D.S.P., nomination rolls of eligible inspectors of Police as per list enclosed as on 01.01.2013 may please be furnished to this Hdqrs. In the enclosed format (Proforme-I and Annexure-A) in the following manner through the respective Range Office by 05.07.2013 positively for holding D.P.C.

1. Nomination rolls should be furnished in six copies.

2. Rewards/ punishments during last five years as on 31.12.2012 and prior to five years along with up-to-date information till date should be correctly calculated and mentioned in appropriate columns of the nomination roll.

3. All major/ minor punishments should be properly flagged in the Service Book and a copy of chart showing rewards/ punishments, duly attested, may be placed under the first page of the Service Book, duly tagged.

4. Original Service Books with up-to-date entries and CCRs upto 31.03.2012 of

the above inspectors should be furnished along with nomination rolls.

5. Nomination rolls of Inspectors of Police who are on deputation to other Estts. may be submitted through the Addi. D.G. of Police, CID, CB, Odisha, Cuttack under intimation to this Hidgrs.

6. The nomination rolls of the officers transferred from one establishment to another establishment within three months prior to 31.05.2013 and those who have not joined yet in their new places of posting will be sent by the Dists./ Estis. where they were posted last. In case any name of eligible inspectors senior to any of the nominees has been omitted in the list, the same should be intimated forthwith to this Hdqrs.

7. Anything adverse about the work and conduct of the officers, if noticed between the period of submission of nomination rolls and sitting of D.P.C. 2013, should be promptly brought to the notice of the Range/ State Police

Hdgrs., Cuttack by Fax/ R.M.

8. Specific information regarding pendency of departmental Prog./ Vig./ Crml. Case should be reflected against the appropriate column of the nomination roll. Besides, details about Vigilance/ Criminal case/ departmental progs./ other confidential report, if any, against the officers, should be furnished in a separate sheet indicating present status along with Xerox copies of the charges and memo of evidence, duly attested. In case of Vig./ Crml. Case the date of charge sheet and cognizance taken may be indicated.

9. In each page of the nomination roll, name and D.P.C. SI. No. of the nominee

should be mentioned.

10.A Certificate should be furnished with the nomination roll to the effect that :-

(a) No officer senior to the nominee (either nominated or superseded) has been excluded.

(b) Entries in the nomination roll have been made correctly.

(c) Correct entries regarding SC/ST category have been made in Col-2 of the nomination roll. The Caste Certificates of the officers belonging to SC/ST category have been affixed to the S.B. duly flagged.

Range authorities are requested to scrutinize the nomination rolls and record their views/ recommendation in each case and furnish the same to this Hdgrs. in five copies together with their S.Bs & C.C.Rs.

All instructions contained in the preceding paragraphs should be adhered to strictly while filling up and submitting the nomination rolls.
