- 2. Recruitment may be made taking into account the numbers of personnel to be deployed basing on the demand survey and cost effectiveness.
- 3. Police personnel deployed in Hirakud/Machhkund will be back to the parent Cadre and consequential vacancies in future may be abolished.
  - 4. No Follower Orderly will be provided in the present context.
  - 5. The Police personnel may be deployed in the industrial belt.
- 6. I.G. and D.I.G. may be provided private vehicles for official use on hire basis in terms of F.D.O.M. No. 34085 dated 29.09.2012.
- 7. Commandant / Dy. Commandant may be allowed to use private vehicles preferably Jeep or Bolcro for official use in hire basis in terms of F.D.O.M. No. 34085 dated 29.09.2012.
  - 8. Field personnel may also be allowed to use Troop carrier on hire basis.

- 9. The expenditure on account of hire cost of vehicle will be charged from the borrowing organizations.
- 10. The cost of expenditure towards salary items, RCM and other allowances applicable to Police personnel of equivalent rank and the Pension, leave salary contribution and other retirement benefits of Police personnel so deployed have to be borne by the borrowing organizations.
- 11. Per person charge should be determined in such a manner that it will not only cover all the aforesaid entitlements but also entire establishment cost of the OISF unit including Headquarter cost as in case of CISF, so that no additional financial burden will be on the State Ex-Chequer.
- 12. All the recruitment for Group 'C' & 'D' posts shall be guided by the new recruitment policy issued by the G.A. Department vide G.A. Department Notification No.32010 Dated 12.11.2013. The posts will be filled up in a transparent manner following the relevant recruitment rules and provision of ORV Act.
