11	Brief of incident	Martyr Jaga Khilla was a Grama Rakhi of Patangi P.S. under Koraput Police District. On 05.06.2015 at about 7.30 PM while he alongwith Dhobulu Khilla (his uncle in-law) were sitting in front of the house of Dhobulu Khilla 03 unknown persons armed with fire arms and covering their faces with towels arrived there and enquired about the identity of Jaga Khilla. When Jaga Khilla disclosed his identity, one of the assailants suddenly opened fire at him. Jaga Khilla entered the house of Dhobulu Khilla to save his life but the unknown assailants chased and fired two rounds on him. They also stabbed Jaga Khilla on his neck using a sharp edged weapon. Jaga Khilla succumbed to the injuries at the spot. In course of investigation it was revealed that the local members of the Naxal outfit were involved in the killing of Martyr Jaga Khilla in cold blood.

18	Description	<p>As per Legal Heir Certificate issued by the Tahasildar, Pottangi, the name of Mother Daimati Khilla is placed as Number 1 Legal Heir and Name of Gangu Khilla as 1<sup>st</sup> wife (having 4 minor children) and name of Basant Khilla as 2<sup>nd</sup> wife ( having 2 minor children). Due to such legal heir dispute between 1<sup>st</sup> and 2<sup>nd</sup> wife of Late G.R. Jaga Khilla the Ex-Gratia payment Rs.5 Lakh already sanctioned from the I.G.P. OPS, Odisha BBSR could not be disbursed. Similarly the application for settlement of Insurance claim could not be processed. However steps are being taken for amicable settlement of the legal heir dispute in shape of an affidavit before the Executive Magistrate and an early payment.</p>
