(i) District Kaverdha (Chattisgarh), Dindori (Madhya Pradesh) and Bhandara (Maharashtra) have been excluded from the purview of awarding Police (Antrik Suraksha Seva) Padak.

(ii) The following districts of Andhra Pradesh, Bihar, Jharkhand, Chattisgarh, Maharashtra, Orissa, Uttar Pradesh and West Bengal will also qualify for the award of "Police (Antrik Suraksha Seva) Padak" subject to the conditions stipulated in the President Secretariat Notification No. 142-Pers/2000 dated 20th September, 2000:-



Subject:- Clarifications on different issues raised by the State Governments for award of Police (Antrik Suraksha Seva)
Padaks to the Police Personnel

Sir.

I am directed to refer to the President's Secretariat Notification No. 142-Pres/2000 dated the 20th September, 2000 and this Ministry's Notifications No. 11026/9/98-PMA dated the 29th November, 2000, 11026/9/98-PMA dated 31st January, 2001 and No.11022/23/03-PMA dated the 27th October, 2003 on the above subject and to say that clarifications on the following issues have been sought by different State Governments:-

- (i) Police personnel posted in non-operational branches like Headquarters, Establishments, MT or WT etc. are eligible for the award of Police (Antrik Suraksha Şeva) Padak if not directly involved in counter insurgency/internal security duties.
- (ii) The eligible officers who have since retired can be granted the Police (Antrik Suraksha Seva) Padak.
- (iii) The enrolled Police officers of the State Police would also be eligible for award of the above said Medal.


- (iv) The above said Medal is being awarded to all those line officers i.e. PC to concerned Range DIG under whose the jurisdiction of the notified districts fall, provided they work for a minimum of 2 years. The Medal is also being awarded to those of the Greyhounds personnel who are engaged in operations in those notified districts for a minimum of 2 years and confirmation has been asked if the procedure adopted is correct.
- (v) The period of two years service should be in one span or it may be into two or more time period.
- 2. The position of the above issues in seriatim is clarified as under:-
- (i) The Medal has been instituted to encourage policemen who perform duty on CI/IS operations in militancy affected areas as notified. Hence, the police personnel who do not render service in counter-insurgency or internal security operations, even if posted in notified areas, are not eligible.
- (ii) For the areas notified vide Government of India notification dated 29.11.2000 and 31.1.2001, police personnel who have since retire, are eligible provided they fulfill the eligibility criteria laid down for award of the medal after 1.1.1989 which is the effective date of institution of medal.
- (iii) The State police personnel who fulfill the criteria are eligible for the medal.
- (iv) The personnel in line office, if they do not participate in operations are not entitled. The Greyhound personnel normally do not continuously remain deployed on CI/ IS operations in the notified areas. They go for operations for short durations and return. As such they are not eligible as the period of deployment in a single span is less than 2 years. However, the police personnel who are deployed for the counter insurgency/internal security operations in the notified areas for a minimum period of 2 years in a stretch would be eligible for the award of the medal.
- (v) The notification issued by this Ministry provides that police personnel who have rendered/render a minimum of 2 years service in counter Insurgency and Internal Security operation in areas specified in the

notification are eligible for the Police (Antrik Suraksha Seva) Padak. Two years service period should be continuous in one span and not piece-meal i.e. two oft more periods. In working out two years service, continuous absence of more than 3 months on leave, attachments, training or other assignments etc. shall be treated as break and for becoming eligible for medal, the person shall have to spend two years continuous period again. Furthermore, total absence on any count should not exceed more than six months.

3. It is therefore requested that while processing the proposals for award of Police (Antrik Suraksha Seva) Padak, the above clarifications may be kept in mind.

I am directed to say that the Police (Antrik Suraksha Sewa) Padak was instituted vide President Sectt's Notification No.142-Prs/2000 dated 20/09/2000. With the approval of competent authority, it has now been decided that Directors General of the Central Police Organisations/State Police henceforth would have the powers to award the Police (Antrik Suraksha Sewa) Padak to the eligible police personnel as per the provisions of the statues and rules notified vide President Sectt. Notification as mentioned above and MHA Notification No. 11026/9/98-PMA dated 27/11/2000 and 31/01/01 (copies enclosed). After award of the medal, each CPO/State will prepare and keep a list of 3. such persons and send the information to MHA in enclosed proforma. The medals would be fabricated & suppplied by this Ministry. With regard to the proposals, which have already been sent to this Ministry, some of them have already been approved and communicated and those which are still to be approved are under

process and decisions will be intimated shortly. All future cases will henceforth be decided by the Heads of Police Organizations i.e. Director General of Police / Director General of CPOs / CPMFs as per the delegated powers.

No.142-Pres/2000-The President is pleased to institute an award for members of Police Forces, Central Police and Security Organisations to recognize their service in Counter-Insurgency Operations and, in this behalf, to make, ordain and establish the following Statutes governing the award which shall be deemed to have effect from the first of January, 1989.

Firstly ~ The award shall be in the form of a medal and styled and designated as the "POLICE (ANTRIK SURAKSHA SEVA) PADAK" (hereinafter referred to as the medal).

Secondly - The medal shall be circular in shape, made of cupro-nickle, 38 millimetres in diameter, fitted to a 38 millimetres long horizontal bar with the inscription "Police (Antrik Suraksha Seva) Padak" with decorative standard fitting and shall have embossed on the obverse a geographical outline of the map of India with a soldier holding an aiming gun and shall have susperscribed the words " पुतिस श्वान्तरिश सुरहा सेवा पदक and subscribed the words "POLICE (ANTRIK SURKSHA SEVA) PADAK-INDIA" in semi-circular shape. A star on either side shall separate the upper and lower semi-circles. On the reverse it shall have Embossed the State emblem in the centre encircled by a decorative wreath having 37 spokes placed on equal distance from each. The State emblem shall have superscribed the words " पुतिस वालों के लिये " and subscribed the words "FOR POLICE FORCES" in circular shape. A star on either side shall separate the upper and lower semi-circles. The words " सत्यमेव जयते " shall be embossed below the National Emblem.

Thirdly - The medal shall be suspended from the left breast by a ribbon of 35 millimetres width. The ribbon shall be navy blue and red in colour. The navy blue colour portion of the ribbon shall be double of the size of the red colour vertically.

Fourthly - The medal shall be awarded to those police personnel including the Central Police Organisations and Security Organisations who have performed/perform service in such conditions and for such periods as may be recognised from time to time by the Government of India for the purposes of this award. Awards may also be made posthumously.

Fifthly - The names o Police personnel who are awarded this medal shall be published in the Cazette of India and a Register of such names shall be kept in the Ministry of Home Affairs by such person(s) as th.

Sixthly - It shall be competent for the President to cancel and annul the award of the above medal to any person and that thereupon his name in the Register shall be erased. It shall, however, be competent for the President to restore any medal, which may have been so forfeited. Every person to whom the said decoration is awarded shall before receiving the same, enter into an agreement to return the medal if his name is erased as aforesaid. Notice of cancellation or restoration in every case shall be published in the Gazette of India.

Seventhly - It shall be competent for the President make rules to carry out the purposes of these Statutes.
