Sub: Institution of Late Bhramarabara Sahu Memorial Bravery Award.

1. Bravery Award in memory of Late Bhramarabara Sahu, Ex-Inspector of Police who had sacrificed his life during the encounter with the dacoits in Balasore district in the year 1941 is being instituted to encourage Police personnel exhibiting acts of exceptional courage or bravery.

2) The Award will be given to four deserving personnel of Odisha Police on the occasion of Odisha Police Formation Day i.e. on 1st April of every year and will consists of citation and cash reward of Rs.25,000/- each.

3) Acts of courage and bravery during anti-extremists operation / exceptional Crime Control / detection / saving life and property at the risk of Life for the preceding calendar year only will be considered. In exceptional cases the Committee may consider previous year cases which have been overlooked but not before 5 years.

The nomination in prescribed proforma (enclosed) should be forwarded to D.G. & I.G. of Police through concerned Range I.G.P/D.I.G.P and IGP (OPS) by 15th January positively.

The nominations should include following information. :
The full name of the recommendee, his designation/posts held and date of birth.

- The date of the incident.
- Brief chronological details of the incident bringing out clearly the act of bravery and the crucial contribution made by the recommendee so as to qualify for the award.
- Number of persons killed or injured if any, in the incident (including police personnel).
- The proposals involving two or more Police personnel in one single action must be sent together with a single citation.
- The role played in the gallant action by each participant / recommendee must clearly be indicated in the citation with their achievements
- In case of joint operation with their Arms used of different units / forces, the role played by other forces / units and their personnel must be properly highlighted.
- A copy of the FIR or the report made to the State Police Authorities, or the State Government about the incident together with legible copies of the post-mortem reports in respect of persons killed and injury reports in respect of persons injured.
- A copy of the report of the Magisterial inquiry or departmental inquiry conducted if any, and whether any judicial inquiry or court decision is pending in this case.
- Integrity certificate in respect of police personnel for whom the award has been recommended. This certificate may also include that the recommendee has not been recommended earlier for the same action.
- No Objection Certificate from the lending department / office in case of deputationist officer / persons.

 - Eligibility for selection :

- Persons who have had either a major punishment any time in their service career or a minor punishment in the last five years or having convicted in a criminal case, shall not be eligible for this award.
- The persons, who are under suspension or against whom either a disciplinary proceeding or a criminal case(s) or a vigilance case(s) is / are pending, shall not be considered for the award till the suspension has been revoked or the proceeding / cases have been finalised, as the case may be.
- All the persons, to be considered for the award, must have vigilance clearance from the appropriate authority.


