Sub : Creation of posts for the Economic Offence Wing (EOW) and the Special Task Force (STF) in Orissa Criminal Investigation Department, Crime Branch.

Sir,

I am directed to convey the sanction of the Governor for setting up of one Economic Offence Wing and one Special Task Force in Orissa Criminal Investigation Department, Crime Branch with creation of 101 (one hundred one) posts of different categories in the scale of pay noted against each with usual D.A. and other allowances as sanctioned by the Government from time to time except in the case of Chartered Accountant, Bank Officer and Peon whose appointment shall be on consolidated monthly remuneration, deputation or otherwise as specified under column 4 of the table below. The posts are sanctioned from the date those are actually filled up. All the posts sanctioned shall be part of the respective State or District cadres and shall be filled up accordingly.
