Sub:- Establishment of 20 (twenty) new Police Station in the State-creation of required posts.

Sir,

I am directed to convey the sanction of the Governor for creation of 340 (three hundred forty) posts of different categories for the proposed 20 (twenty) new Police Stations in the scale of pay noted against each with usual D.A. and other allowances as sanctioned by the Government from time to time except in the case of Assistant Driver whose appointment are on contractual and consolidated remuneration basis. The posts are sanctioned from the dates those are actually filled up.

2. The name of the Police Stations, district in which they are to be located and the Police Station-wise posts sanctioned are given in Annexure-I.

3. The expenditure on account of creation and filling up of such posts shall be met from the existing budget provisional as per the provisions of F.R.B.M. Act, 2005. The non-recurring expenditure may also be met from the existing budget provision.

4. The above posts are sanctioned pending issue of formal notification under section 2 (s) of Cr. P. C. for creation of aforementioned Police Stations. The State Police Headquarters shall take expeditious steps for submitting individual proposals for each Police Stations for issuing such notification in the prescribed manner enclosing the required information and documents.




