

In pursuance of Govt. of Odisha, Home Department letter No.45178/SIS Dt.22.11.2017 regarding allowing Inspector of Police to officiate as In-charge DSP, one selection committee was constituted to examine the suitability of the eligible Inspectors of Police for selection to allow In-charge DSP and as per their recommendation, Inspectors of Police were allowed to officiate In-charge DSP.

As in respect of Inspector Ajay Kumar Mishra of Berhampur district, the information was placed before the Selection Board that OHRC case No.1388/2014 was pending against him and Deptt. Proceeding is contemplated against him, the Selection Board held on 27/28.11.2017 did not assess his case for selection.

Subsequently, on the representation dt.30.11.2017 of Inspector Ajay Kumar Mishra, his case has been examined and it is found that Hon'ble High Court vide their Order No.3 Dt.10.6.2015 passed in Misc. Case No.9795 of 2015 in W.P. (C) No.9993 of 2015 Ajay Kumar Mishra vrs. State of Orissa & others, have stayed the order passed by the Acting Chairman, Odisha Human Rights Commission, Bhubaneswar in OHRC Case No.1388 of 2014 to initiate disciplinary proceeding against Inspector Ajay Kumar Mishra the then IIC, Baidyanathpur P.S. Berhampur.

In view of the stay order imposed by Hon'ble High Court on the order of OHRC, Sri Ajay Kumar Mishra, Inspector of Police, Berhampur dist. is found suitable and he is allowed to officiate as In-charge Dy. Supdt. of Police with the following conditions.

1. The officer shall work as I/c DSP in the same scale of pay as he has been drawing as Inspector of Police.
2. The posting as I/c DSP shall not be treated as promotion.
3. The order to officiate as SDPO and DSP would be without any prejudice to the outcome of any Court cases pending in any Court of Law.

This issues with the approval of DGP.
