In pursuance to Govt. of Odisha, Home Deptt. Notification No. 11400/D&A dt. 28.2.09 the following OASI's of 2002 batch who were deputed for undergoing ASI's course of training at BPSPA, Bhubaneswar / PTC, Angul for a period of one month institutional basic training followed by 3 months field training were appeared in the final examination of ASI's course of training simultaneously from 10.7.2012 to 13.7.2012 are declared to have failed in the subjects mentioned against them. 
