Sub : Introduction of Community Policing in the State.

Ref : Home Department Resolution No.30474/HD.  
Dated, 26th May, 1999 PDAE-107/99.

The Government have approved in the aforesaid Home Department Resolution the operation of Community Policing Scheme in the State, a copy of which is enclosed herewith for ready reference, guidance and implementation at your end. This Resolution should be carefully examined by you and steps are taken to sensitise all Os.I.C. of P.Ss. and Circle Inspectors by explaining to them the provisions of the resolution so that, the scheme becomes operational latest **by the end of August'99 all over the State.**

Please get, therefore, the updated list of Gram Panchayats, Ward of Municipalities/ NACs of your jurisdiction and supply them to Os.I.C./Is.I.C. concerned to select members preferably from each village of the Gram Panchayat or several persons from a Ward of the NAC/ Municipality keeping in view the eligibility and functions of the Surakhya Samiti as enumerated in the aforesaid resolution of the Home Department. The Os.I.C. and Is.I.C. while selecting eligible members for the Surakhya Samities should also consult with the designated Executive Magistrates of the jurisdiction to finalise the list of members of the Surakhya Samiti concerned.

The Range D.Is.G. shall closely supervise the start of the Surakhya Samiti as well as their functioning by ensuring monthly reports from the District Ss.P. of the Range and consolidate/ them for submission as Quarterly report to State Police Hdqrs. as per the format enclosed herewith. These reports are to reach S.P.Hdqrs. in the 1st week of the succeeding quarter.

The Ss.P./ Range D.Is.G. during their official tours should invariably meet the Surakhya Samities for giving them close support to ensure their better functioning. They should also reflect their views through the monthly/quarterly reports to be submitted by the Range D.Is.G. to the State Police Headquarters.
