

POLICE CIRCULAR ORDER NO. - 326107

It has been brought to my notice by the Vice-Chairman, Transparency International India in letter dated the 3rd August, that studies on Corruption on Trucking operation in India was conducted by the Centre for Media Studies(CMS) for Transparency International India. The study revealed bribe is given to police, which includes traffic police, district police, highway patrolling staff and other field functionaries by the defaulting truck/bus operators towards 'show of favour'. As such, a major portion of revenue collected by the authority of police and other departments, remains unaccounted for. Consequently, the Govt. is loosing large amount of revenue which affects the Country's economic growth and, prosperity. In order to ensure good governance, corruption needs to be dealt with in a concerted manner.

It is, therefore, urged that the district Ss.P. may issue suitable instruction to the field functionaries under them to maintain transparency while dealing with defaulting truck/bus operators, and implement the law without show of favour. Stringent action may be initiated against the errant officer/men, if there is allegation, or such activity comes to notice by the Supervising authorities.
