Recruitment of above posts and the posts of Barber, Dhobi, Cooks, Sweeper and Water Carrier sanctioned vide this Department Order No.2463/D&A dt.11.01.02 shall also be filled up direct from the open market on regular scale of pay observing the Government approved eligibility criterion and the manner of selection including reservation rule.

The additional expenditure on this account will be met from the existing budget provision without increasing the over all grant for the current year i.e. 2008-09 as well as for the future as per the provisions of FRBM Act.
