- 4. Details of Departmental proceedings/Vigilance/ Criminal/ HRPC related cases alongwith other allegations if any pending/contemplated against Armourer Havildar Major be properly reflected in the appropriate column of the Nomination Rolls. A copy of charge thereof be furnished.
- 5. A copy of Caste Certificate duly attested in respect of SC/ST candidates must be made available in the Service Book for reference.
- 6. In the event of the Armourer Havildar Major is retired/expired/transferred that should be intimated to the concerned Estt./this Hdqrs. immediately for further action.
