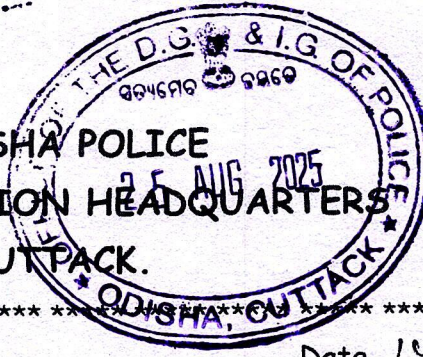

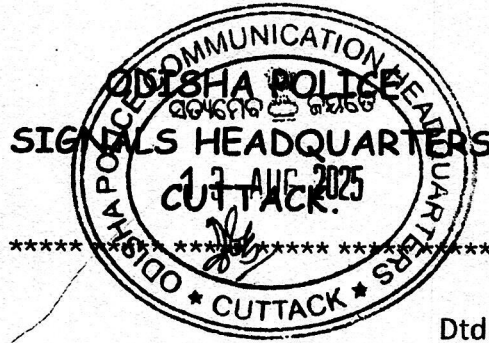

Chandrakala Behera, Head Clerk for finalisation of the gradation list of Inspr. (Commn.), held on Dtd. 12.08.2025 in the office chamber of S.P Signals, Odisha, Cuttack.

The tentative gradation list of Inspr. (Commn.) as on 01.12.2024 was floated in Odisha Police Website on 31.12.2024 inviting objections, if any from the incumbents. By the time 03 objections were received. To finalise the gradation list, S.P Signals has formed one committee under his chairmanship companion with Smt. Babita Tripathy, OPS Dy.S.P Signals and Smt. Chandrakala Behera, Head Clerk Signals as members to examine the objections so received and to finalise the same.

The meeting held today i.e on 12.08.2025 at 11.00 A.M in the office chamber of Supdt. of Police Signals, Odisha Cuttack. The committee made thread bare discussions on the objection in the matter of the fixation of inter se seniority of Inspr. (Commn.).

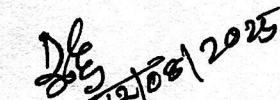
The Board observed that tentative gradation list of Inspr.(Commn.) as on 01.12.2024 was published in Odisha Police web site on 03.12.2024 wherein names of 17 Inspr.(Commn.) were found place. In the meantime, 8 Inspr. (Commn.) have already retired from Govt. Service on superannuation pension. Among the retired Inspr.(Commn.), Saroj Ranjan Mohapatra had placed his objection. As he is retired from Govt. Service, his grievance on seniority list was not taken into consideration and his name does not find place in the present seniority list of Inspr.(Commn.).

Further, another 2 objections each from 1. Inspr.(Commn.) Prasanna Kumar Behera and 2. Inspr.(Commn.) Jyotimohan Mohanty were received, the compliance of which have been made by the Board members. The details of objection and compliance is annexed herewith as Annexure-A and the final seniority list of existing 9 Inspr. (Commn.) is finalised and attached herewith as Annexure-B to this proceeding.

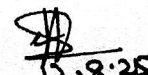
The meeting ended with thanks to the chair.
