## **OFFICE MEMORANDUM**

Sub: Clarification on admissible Allowances in respect of All India Services (AIS) officers working under the State Government of Odisha

In Supersession of Finance Department O.M. No.6759/F dt.15.03.2024, State Government have been pleased to decide that All India Services (AIS) officers working under the State Government shall be entitled to avail following allowances at par with AIS officers working under Government of India.

- (A) Other allowances not mentioned in the table above (such as Briefcase Allowance, Night Duty Allowance, etc.) extended to AIS officers working under Government of India shall not be extended to AIS officers working under State Government of Odisha. As far as Deputation Allowance is concerned, AIS officers of Odisha cadre shall not be eligible for this allowance when they are posted in any deputation post under Government of Odisha or its organisations. However, AIS officers of Odisha cadre on inter-State deputation to other cadres or AIS officers of other cadres on inter-State deputation to Odisha shall be eligible for Deputation Allowance as per terms and conditions of such deputation sanctioned by Department of Personnel & Training, Government of India.
- (B) However, AIS officers working under State Government of Odisha will be eligible to avail allowances, other than those mentioned in the table above, if such allowances are being extended to State Government employees by Government of Odisha. The quantum of such allowances shall be at par with Odisha State Government employees of corresponding rank.

This shall take effect retrospectively from 15.03.2024.
