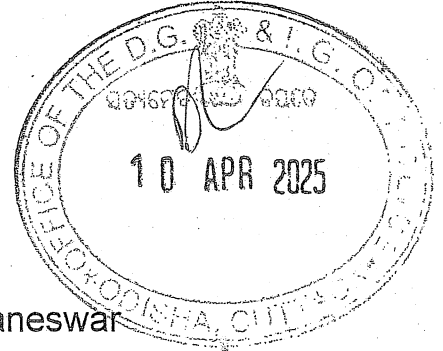


2. The aforementioned newly created posts shall carry usual pay, D.A and other allowances as sanctioned by the Government from time to time.
