Sub: Creation of 20 new Cyber Crime & Economic Offences (CC & EO) Police Stations across the State along with strengthening of existing 14 CC & EO Police Stations

(ii) Proposal of State Police Headquarters furnished vide Noting 60 to Noting 64 in their OSWAS file : PT1-DP-PLCY-CREAT-0008-2020

Sir,

I am directed to convey the sanction of Governor for creation of 987 new posts in various ranks (**as detailed at Annexure**) for 20 newly created Cyber Crime & Economic Offences (CC & EO) Police Stations and strengthening of existing 14 Cyber Crime & Economic Offences (CC & EO) Police stations in the State, to overcome the rising menace of cyber-crimes and economic offences, in the pay level as mentioned against each and other allowances as sanctioned by the Government from time to time.

2. 28 posts of Constable (Communication) created earlier for 14 existing CC & EO Police Stations vide Home Department's letter no. 44384/D&A dated 15-12-2021 are hereby abolished.

3. The afore-mentioned regular posts are created with the stipulation that the recruitment shall be made in a transparent manner following the relevant recruitment rules and provisions of ORV Act.

The promotional posts , if any, are to be filled up observing relevant Rules and ORV Act.

4. In line with hiring of 649 vehicles with 2 drivers for 649 Police Stations (*which includes 14 CC & EO PS created earlier*), communicated vide Home Department letter no. 48150/M&D dated 21-12-2024 (*copy enclosed*); hiring of additional 20 vehicles is allowed for 20 newly created CC & EO Police Stations with same terms and conditions.

5. While the 14 existing CC & EO Police Stations and Cyber Crime Police Station at CID-CB shall continue to operate with 6 Experts (@ 2 - Cyber Forensics Expert, 2 - IT Expert & 2 - Finance & Accounts Analyst) per CC & EO Police Station as agreed upon earlier vide this

Department's letter no. 44384/D&A dated 15-12-2021; the 20 newly created CC & EO Police Stations shall operate with engagement of 4 Experts (2 - IT Expert, 1 - Cyber Forensic Expert & 1 - Finance & Accounts Analyst) in each CC & EO Police Station.

Thereby, a total of 170 Experts shall be engaged on outsourcing basis as detailed below with proposed monthly remuneration, through third party, in consultation with OCAC under E&IT Department.

Sub: Creation of 14 Cyber Crime & Economic Offences (CC & EO) Police Stations across the State

Sir,

I am directed to convey the sanction of Governor for creation of 154 posts in various ranks, in 14 newly created Cyber Crime & Economic Offences (CC & EO) Police stations in the State to overcome the rising menace of cyber crimes and economic offences, in the level of pay mentioned against each and other allowances as sanctioned by the Government from time to time.

2. These 14 newly created Cyber Crime & Economic Offences Police Stations include three existing Cyber Crime Police Stations at Sambalpur, Berhampur and Rourkela which are renamed as CC & EO PS with immediate effect and their administrative control shall henceforth be under concerned district Superintendent of Police.

3. These 154 posts are being created in lieu of immediate abolition of equal number of posts in four different Establishments under Odisha Police as indicated below read with details as at Annexure.

4. The afore-mentioned regular posts are created with the stipulation that the recruitment shall be made in a transparent manner following the relevant recruitment rules and provisions of ORV Act. The base level posts meant for direct recruitment shall be filled up on a contractual basis initially following the relevant recruitment rules and provisions of ORV Act as well as the stipulations contained in erstwhile GA Department Notification No. 32010/Gen. dated 12-11-2013 read with Notification No. 19574/Gen. dated 12-09-2017 and Notification No. 1147/Gen. dated 17-01-2014 read with Notification No. 19569/Gen. dated 12-09-2017 and subsequent notifications in this regard. The service condition and emoluments of the posts so created will be governed by the said notification of erstwhile GA Department.

The promotional posts, if any, are to be filled up observing relevant Rules and ORV Act.

5. The districts where these CC & EO Police Station shall be established along with the sanctioned strength of executive police personnel and experts engaged on outsourcing basis through service providing agency in each of these Police Stations is given in the table below.


6. The following stipulations shall be scrupulously followed while engaging afore-mentioned 90 experts on outsourcing basis through service providing agency.

- a. These experts are to be engaged on contractual basis for fixed tenure as their work needs constant knowledge up-gradation.
- b. In order to overcome knowledge redundancy, fresh experts shall be engaged with updated domain knowledge periodically by replacing the existing personnel after expiry of their tenure.
- c. Prior to engagement of these experts, job chart delineating their roles and responsibilities shall be finalized.





Sub: Approval of the proposal for providing one additional 4-wheeler vehicle (649) to each police station across the state on hiring basis.

Sir,

In inviting a reference to the OSWAS No. DP-SPLY-MISC-0124-2024 on the subject cited above, I am directed to say that, proposal for hiring of 649 Scorpio vehicles along with 2 drivers to each Police Station across the state has been approved subject to the stipulations mentioned below.

- Maximum cost towards hiring vehicle along with additional driver shall be Rs. 55,000/- per month , exclusive of GST.
- As the Scorpio vehicle is the second vehicle to each Police Station, the monthly ceiling of both the vehicle shall be within 2000 kms per vehicle per month.
- Hiring provisions laid down in FD OM 22924/F Dated 14.08.2023 shall be followed.
- Tenure of the contract, mileage and prescribed ceiling of usage as laid down in FD OM 22924/F Dated 14.08.2023 shall be followed.
