11	Brief of incident	On 21.04.2025, OAPF/353 Lokanath Sabar along with other staff of CRRI P.S. were commanded for night patrolling duty in PCR-15 under the jurisdiction of CRRI P.S., Cuttack UPD. During the course of duty, at about 3.45 AM, on the intervening night of 21/22.04.2025, while performing patrolling duty on Mahanadi river embankment Ring Road near Gatiroutpatna, a sand loaded Hywa Truck bearing Registration No.OD-02-U-1955 came in a rash and negligent manner and dashed against the PCR-15 from the front side. As a result of the accident, OAPF/353 Lokanath Sabar and Home Guard Driver had succumbed to their injuries at the spot. In this connection, a case has been registered at Cuttack UPD CRRI P.S. vide P.S. Case No.90 dated 22.04.2025 U/s 281/ 125(a)/ 125(b)/ 106(1) BNS Act and is being investigated into.
