Establishment of Abhayachandpur, Thekoloi and Badmal Police Stations and upgradation of Kaliapani, Jenapur, Knuntuni, Khumpura and Bamebari Out Posts to Police Stations as part of strengthening Police Stations in the Industrial clusters of the State.

I am directed to convey sanction of the Governor for creation of 170(One hundred seventy) posts of different categories for the proposed Abhayachandpur Police Station in Jagatsir ghpur district, Thelkoloi Police Station in Sambalpur district, Badmal Police Station in Jharsuguda district and upgradation of Kaliapani and Jenapur Out Posts in Jajpur district, Khuntuni Out Post in Cuttack district, Jhumpura and Bamebari Out Posts in Keonjhar district into Police Stations in the scale of pay noted against each with usual D.A. and other allowances as sanctioned by the Government from time to time except in the case of Assistant Drivers whose appointment are on contractual and consolidated remuneration basis. The posts are sanctioned from the dates those are actually filled up. All the posts sanctioned shall be part of the respective State or District cadres and shall be filled up accordingly.
