Sub:- Augmentation of staff strength of the industrial cluster Police Stations of the state.

I am directed to convey the sanction of the Governor for creation of 216 (two hundred sixteen) posts of different categories in 20 (twenty) Police Stations of the industrial clusters located in 9 (nine) districts in Orissa as given in the table below, in the scale of pay noted against each with usual D.A. and other allowances as sanctioned by the Government from time to time except in the case of Assistant Drivers whose appointments are on contractual and consolidated remuneration basis. The posts are sanctioned from the dates those are actually filled up. All the posts sanctioned shall be part of the respective State or District cadres & shall be filled up accordingly.
