

Hence the newly created Group-C posts may be filled up on contractual basis in a transparent manner following the relevant recruitment rules and provision of ORV Act and their emoluments and service conditions will be determined by the new recruitment rules to be notified by G.A. Department.

5. The Accountant General, Odisha, Bhubaneswar is being informed of the matter.


