Sub:- Creation of posts for Odisha Auxiliary Police Force constituted vide
Resolution No. 40725 dated 16/X/2012

Sir,

I am directed to convey the sanction of the Governor for creation of 4855 posts of Constable in Odisha Auxiliary Police Force for absorption of 4855 tribal youths recruited as Special Police Officers in the scale of pay of Rs.5200-20200 + Grade Pay Rs.2000/- with usual D.A. and other allowances as admissible from time to time with effect from the date the posts are actually filled up subject to stipulation that equal number of regular posts of Constables/Sepoys will be kept in abeyance in a phased manner during the period 2012 to 2020 as follows..


Simultaneously equal number of posts of Special Police Officers created vide G.O. No.44616 dated 27.09.2008, No.4264 dated 28.01.2009 and No.51648 dated 18.11.2009 shall be abolished in lieu of equal number of posts of Constables actually filled up in the Odisha Auxiliary Police Force.

Further the present vacancies of 745 posts of Special Police Officers (5600-4855) are also hereby abolished forthwith.

The charge is debitable under "Demand No.1-2055-Police - Non Plan-109-District Police-0321- District Organisation-01004-Salaries".

This has been concurred in by Finance Department in their UOR No.379/GS-I, dt.08.08.2012.


