Pursuant to earlier Order of Hon'ble High Court, Orissa, the petitioners who filed WP(C)s for getting upper age relaxation to apply for the posts of Sepoys / Constables in Battalions in response to Detailed Advertisement No. 02 / SSB, dtd. 22.09.2024, Addendum Notice No. 04/SSB, dtd.23.10.2024 were allowed to submit applications online vide Notice No.05/SSB, Date 23.10.2024 and Notice No. 06/SSB, Date 29.10.2024 by visiting Odisha Police website <https://odishapolice.gov.in> from 01.11.2024 (10 AM) to 15.11.2024 (10 PM) by clicking on an exclusive link ***“Registration for Petitioners only vide order of Hon'ble Court who have filed WP(c)s”*** subject to fulfilment of other eligibility criteria as prescribed in the Advertisement, other than criteria for upper age limit. It has already been declared and published in the Newspapers and Candidates' Portal that the Computer Based Recruitment Examination (CBRE) for the post of Sepoys / Constables will commence from 07.12.2024 onwards on multiple days and batches vide Notice No.07/SSB, dtd.30.11.2024. In the mean time pursuant to Order, Dated 05.12.2024 of Hon'ble High Court passed in WP(C) No.26079 of 2024 filed by Bisheshawar Biswal & Ors versus State of Odisha & Ors along with WP(C) No.24545, 24685, 24765, 24911, 25016, 25047,

25144, 25155, 25199, 25203, 25221, 25271, 25349, 25499, 25536, 25558, 25677, 25736, 25875, 26668, 26888, 26898, 26902, 26925, 27076, 27084, 27095, 27244, 27386, 27464, 27562, 27597, 27705, 27793, 27803, 24845, 29403, 28118, 28630, 26790, 28647, 27662, 27942, 29002 and 29159 of 2024, the State Selection Board has been directed to facilitate the submission of applications through online for the parties to the present batch of Writ Petitions , who have not applied so far and who are otherwise eligible.

Hence, it is for information of these petitioners only that they can submit their Online Applications from 06.12.2024 (06:00 Hours) to 07.12.2024 (06:00 Hours) by clicking on the link ***“Registration / Submission of Online Application for New Petitioners only”*** on the application portal for Sepoys/Constables in Battalions by visiting Odisha Police website <https://odishapolice.gov.in>. They can also correct / edit their applications during the same period, if required. The link for Mock Test is available on the portal. The Petitioners may go through this link for their practice. Further, these Petitioners are also advised to download their Admit Cards from 09.12.2024 (10:00 Hours) onwards to know details about the Examination Schedule and location of Examination Centre. No further extension for submission and correction of online applications after the above specified period will be allowed. The Petitioners can opt for their choice of Examination Centres in order of preference in the portal. But, the State Selection Board reserves the right to fix the examination centres as per its discretion basing on the availability of examination centres.
