

## ODISHA POLICE STATE HEADQUARTERS CUTTACK.

OFFICE ORDER No. 3542 /Pers-I,

The case of S.I. Anjali Sa of Nayagarh district (CSB SI.No.530) was taken into consideration by the Spl. CSB for the year 2025 held on 08.10.2025 and subsequent dates for promotion to the rank of Inspector of Police, but the findings of the CSB regarding her promotion was kept in an individual sealed cover due to pendency of Nayagarh District Proceeding No.22/2025 against her. In the meantime, Nayagarh District Proceeding No.22/2025 has been disposed off by S.P., Nayagarh wherein she has been awarded one minor punishment i.e. "Censure in SB" vide Nayagarh D.O.No.1272 dtd 25.09.2025.

After disposal of the proceeding, S.I. Anjali Sa submitted a representation on dtd 13.10.2025 for consideration of her promotion to the rank of Inspector of Police against the Spl. CSB-2025. The matter was examined at State Police Hdqrs. and placed before the DGP. As per the orders of the DGP, the sealed cover containing the findings of the Spl. CSB for the year 2025 in respect of S.I. Anjali Sa of Nayagarh district was opened on 19.11.2025 and found that she has been selected by the Spl. CSB for the year 2025 held on 08.10.2025 and subsequent dates vide CSB Sl. No.530.

Having been selected by the Spl.CSB 2025 held on 08.10.2025, S.I. Anjali Sa (Spl. CSB Sl. No.530 of 2025) of Nayagarh district is allowed promotion to the rank of Inspector of Police with effect from the date her immediate junior Ex. S.I. Anil Kumar Nayak (ST) of Cuttack district now Inspector of Police in Khordha District (Spl. CSB Sl. No.531 of 2025) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 3318/Pers.I dtd 10.10.2025. Accordingly, her seniority in the rank of Inspector of Police is fixed above Ex. S.I. Anil Kumar Nayak now Inspector of Police.

Her pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of her immediate junior was allowed promotion to the rank of Inspector of Police. She is not entitled to any financial benefits for the period she has not actually worked in the higher-grade post.

Her promotional posting will be decided by the Police Establishment Board.
