Sub.: **Election of office bearers of Odisha Police/OSAP
Havildar, Constable & Sepoys Confederation.**

It has been decided to conduct the election of the office bearers of the Odisha Police/ OSAP Havildar, Constable and Sepoys Confederation on **16.11.2024** in each Unit i.e. in the Districts/Battalions/ Establishments in accordance with Rules for the Odisha Police/OSAP Havildar, Constable & Sepoys Association and Confederation and amendment to the Rules issued vide S.P. Hdqrs. Letter No.2766/Con dated 6.5.2002 and No.68/Con dated.05.01.2004.

Sri Praveen Kumar, IPS, I.G. of Police, (Personnel), Odisha will be the Central Returning Officer at the Central Level and he will be assisted by Sri Pradeep Kumar Dalei, OPS (S), AIG of Police (Personnel), Odisha, Cuttack and Sri Bamdev Singh, OPS(S), AIG of Police (Prov.), Odisha, Cuttack.

The time schedule for the entire election process will be as under:-

10.	Polling of votes	16.11.2024 (from 9 AM to 12 Noon)
11.	Counting of votes and declaration of result.	19.11.2024 (from 8 AM onwards) at OSAP 6 th Bn. Hdqrs., Cuttack under the Chairmanship of Central Returning Officer.

The Supdts. of Police/ Commandants / Heads of Establishments will be the Returning Officer at their respective Units i.e. Battalions/Districts/Establishments level and will be responsible for conduct of voting at their respective Districts/ Battalions/ Establishments. They will arrange ballot boxes for the purpose. After casting of votes, the ballot boxes will be properly sealed and despatched under proper escort. The unused ballot papers will also be returned in sealed packet. The Returning Officer will send a specimen of the seal used in a sealed cover. It should be ensured that the ballot boxes are deposited at OSAP 6th Bn. Hdqrs. by **17.11.2024** evening without fail. Commandant, OSAP 6th Bn., Cuttack will receive the ballot boxes after proper checking and keep them at a safe place under proper guard. The counting of votes will be held at the OSAP 6th Bn., Cuttack on **19.11.2024 at 9 AM.**

As per the Rule 27(a) of Rules for the O.P./OSAP Havildar, Constable & Sepoys Confederation, amended vide S.P.Hdqrs. letter No.2766/Con. Dt.06.05.2002, five members of each Branch Association will cast their votes in the polling for the election to the Confederation of the respective District/Estt./Battalion. Out of the five members, the President and Secretary of Branch Associations will be automatic members to vote in the polling. The remaining three members are to be nominated by voting by office bearers and executive members of the Branch Associations. In this connection instructions issued to all Heads of Police Establishments vide this Hdqrs. R.M.No.3077/Con. Dt.20.5.2002 may please be referred to.

The Confederation will bear the cost of printing of ballot papers and other stationery required. The General Secretary / Treasurer of the last Confederation will liaise with the Central Returning Officer (I.G. of Police, Personnel) concerning expenditure relating to printing of ballot papers, stationery etc..

AIG of Police (Personnel), Odisha/ AIG of Police (Provisioning) will assist the Central Returning Officer i.e. I.G. of Police (Personnel), Odisha, Cuttack in printing of ballot papers etc. and in despatch of ballot papers to Units.

The Central Returning Officer (I.G. of Police, Personnel) has the power and authority to adjudicate on disputes and take decision to resolve them. His orders are final.

President/Secretary of the Branch Associations of your District/ Battalion/ Establishment may please be informed of this.
