Change of Cadre of Constables in District Cadre-2025.

In view of prescribed provisions for Change of Cadre of Constables of District Cadre in the Odisha Police Service (Method of Recruitment and Conditions of Service of Constables) Order, 2021 communicated vide Home Department Notification No. 31202/D&A, dtd. 04.09.2021 under Appendix-A, applications in prescribed Form duly filled in are invited from the eligible and willing Constables of your District for consideration of Change of Cadre of Constables for the year-2025.

Following shall be followed in inviting and sending applications of eligible Constables.

- The Provisions of Change of Cadre as outlined under Appendix-A of the Recruitment Rules
 of Constable may please be circulated among all Constables of your District including those
 who are on deputation.
- 2. All applications in prescribed Form under **Annexure-1** of Appendix- A of Home Department Notification No. 31202/D&A, dtd. 04.09.2021 should have been filed by the willing and eligible Constables and submitted to their Parent Cadre Controlling Authority.
- 3. The eligibility criteria prescribed under the Appendix-A of the Recruitment Rule is that Constable applying for Change of Cadre must have completed minimum 08 (Eight) years of service as on 01.01.2025. He/ she must have completed minimum of 06 (Six) years of service in his/ her parent cadre including the period spent in SOG/SIW, in case the Constable has ever been posted in SOG/SIW. Period spent in SOG/SIW in the rank of Battalion Sepoy/ Constable and subsequently redeployed as Constable in District cadre may not be taken into account for calculation of 6 Years in Parent Cadre. Eligibility period of 8

- years of service in respect of Battalion Sepoy/ Constable redeployed as Constable in District cadre shall be counted only from the date of their joining as Constable in District cadre.
- 4. Constable Band/ Beguiler/ Carpenter/ Mochi/ Tailor/ OAPF/ Driver are not eligible for change of Cadre. Hence, their applications, if any may be rejected at District Level.
- 5. As per Para-6 of the Appendix-A of the Recruitment Rules, "the Constable applying for change of Cadre must have good service record. He must not have any Major punishment or more than 5 (Five) minor punishments to his discredit during his entire service career and no Departmental Proceeding or Criminal Proceeding or Vigilance case or Human Rights Protection Cell related case shall be pending against him. "Hence, while forwarding the application of any willing Constable, the SsP/DCsP may please verify the service record thoroughly and if any applicant his found ineligible as per the aforementioned provisions, his/ her application may please be rejected at District level under intimation to the applicant with reasons thereon.
- 6. SsP/ SsRP/ DCP shall forward applications of Constables who belong to their district cadre.
- 7. Willing Constables applying for Change of Cadre may be briefed with the undertaking to forgo their seniority for promotion to the rank of Havildar and ASI of Police, in case their cases are considered for Change of Cadre in a new District.
- 8. As per provisions of Change of Cadre prescribed under the Recruitment Rules, Change of Cadre in any particular District can only be considered against 10% vacancy in the rank of Constable in that District. The category wise vacancies earmarked for consideration of Change of Cadre @ 10% in different district is enclosed herewith as **Annexure-2**. The same may be widely circulated among all willing Constables applying for change of cadre.
- 9. Applications of non-eligible Constables shall be rejected at District level and list of rejected cases with reasons may be published and circulated in your district.
- 10. Constables those who are submitting that their spouse is serving as Constable in any other District, the fact may be verified from the respective District SsP/ SsRP/ DCsP. Without proper verification, the application shall not be sent to this Hdqrs. In case Spouse is serving in Odisha Police other than District Constable, Lance Naik/ Havildar, it shall not be treated as Spouse case for the purpose of Cadre Change.
- 11. Unnecessary documents such as representation, medical documents etc shall not be sent with the applications.

- 12. After verification of all information furnished by the Constable in his/ her application may please be certified to be correct as per records available in your District. Required columns for Cadre Controlling Authority may please be filled in and be signed properly.
- 13. Detail information in a format attached herewith as **Annexure-3** may please be furnished in a separate sheet to place the same before the Cadre Change Board.
- 14. Category to which the Constable appointed / belongs must be specified in the format after proper verification from Service Book, Candidate register. The select list of the recruitment test may also be verified, if required to ascertain the category to which the Constable selected and appointed. Reserved category candidates appointed against UR category vacancy shall be placed under UR category.
- 15. Constables whose application was sent by your Office at any time in the past and whose case has not been considered for cadre change till date shall also apply afresh as per their eligibility for cadre change-2025.
- 16. Incomplete/ ineligible applications may not be sent to this Hdqrs.
- 17. All complete/ Verified/ Signed applications of Constables of your District alongwith information sheet may please be sent to this Hdqrs. directly under intimation to Range IsG/ DIsG of Police, so as to reach at this Hdqrs. on or before **28.02.2025**. After the last date, no application shall be entertained.
- 18. Applications in any other form shall not be undertaken for Change of Cadre. Applications only in prescribed Form under **Annexure-1**, complete and verified and submitted (T) the Parent Cadre Controlling Authority shall only be placed before the Board for necessary consideration.
- 19. While furnishing past posting details of the Constables in Application Form, the Cadre Controlling Authority may specify past posting details in different District/ Police Establishments where salary was drawn only. Posting details of Police Station/ Different Cell within the District/ Training Centre (During Basic Training) etc. shall not be furnished.
- 20. All applications in a consolidated manner, information sheet in **Annexure-3** shall be sent (T) email ID **pers1.hqrs@odisha.gov.in** only.
- 21. Information sheet in **Annexure-3 may also be sent** in the same e-mail ID in **Microsoft Excel Format** for utilization of the data in State Police Hdqrs.
