In pursuance to the Order No.1, dtd. 28.11.2023 of Hon'ble High Court of Orissa passed in WPC No.37823 of 2023 filed by Sri Parameswar Goswami, Visty (Group-D) & another and Orders passed by the DGP on 08.08.2024, the Special DPC for promotion of Group-D to Junior Clerk (Group-C) in DPO Cadre was held on 04.11.2024 according to their seniority without following reservation principles (irrespective of the category) as per Section-4 of ORV Act. 


