The case of Ex. S.I. Anup Kumar Tirkey (ST) of BTI, Burla (now Inspector of Police in Angul district) (CSB SI. No.32 of 2022) was taken into consideration by the CSB 2016 held on 25.05.2016, Spl. CSB 2017 held on 22.08.2017, CSB 2019 held on 19.06.2019, CSB 2021 held on 08.02.2021, Spl. CSB 2021 held on 08/09.11.2021 and CSB 2022 held on 23.11.2022 for promotion to the rank of Inspector of Police, but the findings of the CSB regarding his promotion was kept in a sealed cover due to pendency of Bhubaneswar UPD Proceeding No.50/15 & 44/17 against him. In the meantime, both Bhubaneswar UPD Proceeding No. 50/15 & 44/17 have been disposed of finding him not guilty of the charges levelled against him vide Bhubaneswar UPD Order No.5743 dtd 14.12.2019 and No.2324 dtd 17.05.2023 respectively.

After disposal of the above proceeding, Ex. S.I. Anup Kumar Tirkey has submitted a representation for consideration of his retrospective promotion to the rank of Inspector of Police from the year 2016. The

matter was examined at S.P. Hdgrs. and placed before the DGP.

As per the orders of the DGP, the sealed cover containing the findings of the CSB for the year 2016, 2019, 2021, Spl. CSB 2021 & CSB 2022 in respect of Ex. S.I. Anup Kumar Tirkey was opened on 21.11.2024 and found that he has not been selected by the CSB for the year 2016, CSB 2019, CSB 2021, Spl. CSB 2021 and has been selected by the CSB for the year 2022 vide CSB SI, No.32 of 2022.

The findings of the Spl. CSB 2017 in respect of SI Anup Kumar Tirkey had already opened on

23.08.2023 and found "not selected" by the Spl. CSB 2017.

Having been selected by the CSB 2022 held on 23.11.2022, Ex. S.I. Anup Kumar Tirkey is allowed promotion to the rank of Inspector of Police retrospectively with effect from the date his immediate senior Ex. S.I. Sushanta Kumar Pradhan (ST) of Ganjam district (now Inspector of Police in Subarnapur district) (CSB SI. No.31 of 2022) was allowed promotion to the rank of Inspector of Police vide State Police Hdgrs. Office Order No. 987/Pers.I dtd 29.11.2022. Accordingly, his seniority in the rank of Inspector of Police is fixed below Ex. S.I. Sushanta Kumar Pradhan (now Inspector of Police).

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate senior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher-grade post.
