OFFICE ORDER No. **207** /Pers-I, Dated — **19.02.2025**

The case of Ex. S.I. Sita Kisan (ST) of Jharsuguda district (Spl.CSB Sl.No.55 of 2021) (now Inspector of Police in Vigilance Organisation) was taken into consideration by the CSB for the year 2021 held on 27.05.2022 for promotion to the rank of Inspector of Police, the CSB did not consider her case for promotion to the rank of Inspector of Police due to having a major punishment of "One Black Mark" during preceding five years of the Spl. CSB 2021 held on 27.05.2022.

Against the order of major punishment "One Black Mark", SI Sita Kisan had submitted an appeal petition before the I.G. of Police, NR, Sambalpur to exonerate from the charges leveled against her. On consideration of her appeal petition, the I.G. of Police, NR, Sambalpur reduced the major punishment "One Black Mark" to minor punishment "Censure in SB" in Jharsuguda District Proceeding No.12/2020 which was published vide Jharsuguda D.O.No.689 dtd 26.07.2024.

Thereafter, S.I. Sita Kisan of Jharsuguda district has submitted a representation for consideration of her retrospective promotion to the rank of Inspector of Police from the date when her juniors were promoted to the rank of Inspector of Police vide State Police Hdqrs. Office Order No.561/Pers.I dtd 06.06.2022.

The matter was placed before the DGP. Upon consideration of her representation, the DGP has been pleased to pass order to hold a Spl. CSB held on 04.02.2025 to consider the case of S.I. Sita Kisan of Jharsuguda district (now Inspector of Police) for retrospective promotion to the rank of Inspector of Police against the Spl. CSB 2021 held on 27.05.2022.

Having been selected by the Spl. CSB held on 04.02.2025, Ex. S.I. Sita Kisan of Jharsuguda District (now Inspector of Police in Vigilance Organisation) is allowed promotion to the rank of Inspector of Police retrospectively with effect from the date her immediate junior Ex. S.I. Surya Prakash Nayak (ST) (CSB Sl. No.56 of Spl. CSB

2021) of Malkangiri district (now Inspector of Police in Vigilance Organisation) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 561/Pers.I dtd 06.06.2022. Accordingly, her seniority in the rank of Inspector of Police is fixed above Ex. S.I. Surya Prakash Nayak (now Inspector of Police).

Her pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of her immediate junior was allowed promotion to the rank of Inspector of Police. She is not entitled to any financial benefits for the period she has not actually worked in the higher-grade post.


