OFFICE ORDER No. **208** /Pers-I, Dated - **19** - 02.2025

The case of Ex. S.I. Dillip Kumar Sahoo (B) of Angul district (CSB Sl.No.174) (now Inspector of Police in Nuapada district) was taken into consideration by the CSB for the year 2021 held on 08.02.2021 for promotion to the rank of Inspector of Police, but the findings of the CSB regarding his selection was kept in a sealed cover due to pendency of Angul district Proceeding No.09/2019 against him. Meanwhile, Angul district Proceeding No.09/2019 has been disposed of by awarding with a one minor punishment i.e. "Censure in S.B." by the DGP, Odisha, Cuttack communicated vide State Police Hdqrs. Memo No.29956/Appeal dtd 28.07.2022.

After disposal of the above proceeding, Ex. S.I. Dillip Kumar Sahoo (B) has submitted a representation for consideration of his retrospective promotion to the rank of Inspector of Police against the CSB 2021 held on 08.02.2021. The matter was examined at State Police Hdqrs. and placed before the DGP.

As per the orders of the DGP, the sealed cover containing the recommendation of Spl.CSB-2021 held on 08.02.2021 was opened on 02.01.2025 and found that Sri Dillip Kumar Sahoo (B) has been selected by the CSB for the year 2021 vide CSB Sl.No.174.


Having been selected by the CSB 2021 held on 08.02.2021, Ex. S.I. Dillip Kumar Sahoo of Angul District (now Inspector of Police in Nuapada district) is allowed promotion to the rank of Inspector of Police retrospectively with effect from the date his immediate junior Ex. S.I. Gopal Chandra Karna (CSB Sl. No.175) of Mayurbhanj district (now Inspector of Police in Balasore district) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 337/Pers.I dtd 29.04.2021. Accordingly, his seniority in the rank of Inspector of Police is fixed above Ex. S.I. Gopal Chandra Karna (now Inspector of Police).

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate senior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher-grade post.
