Selection Committee for selection of Sepoys/Constables of OSAP Battalions/ OSAP (Special Security) Battalions/ Special Security Battalion, Bhubaneswar/ India Reserve Battalions/ Special Indian Reserve Battalions for their redeployment as Constable in different districts/Establishments held on 29/07/2021 selected 396 Sepoys/Constables of Battalions on the basis of the criteria as per Home Department Notification No.20586, dtd.08.06.2021 i.e "Sepoys/Constables have not been inflicted with any Major punishment or more than five (5) minor punishments to his discredit during his entire service career and no Departmental Proceeding or Criminal Proceeding or Vigilance case or Human Rights Protection Cell related case shall be pending against him". Accordingly O.O was issued for their redeployment as Constables to District vide S.P Hdqrs. O.O No. 857/Pers.-II, dtd.30.07.2021.

Some Sepoys/Constables having major punishments or more than five (5) minor punishments/ CB/HRPC/Vigilance related cases were not selected by the above Selection Board, filed writ petitions No.6100/2022 & batch of cases, in which the Hon'ble High Court vide common Judgment dtd. 04.11.2024 directed the opposite parties to consider the case of the petitioners and similarly situated other persons, in terms of the OPS order, 2010 as it stood prior to the amendment in June, 2021, against the vacancies for the year 2021.

Accordingly, on the basis of the above judgment of the Hon'ble High Court and orders of Government thereon, a Selection Committee held on 18.06.2025, selected the following Sepoys/Constables for their redeployment as Constable to different districts/establishments.
