The Central Selection Board for the year-2024 was held on 30.12.2024 for promotion of ASIs (in different Technical Trades) to the rank of S.I (in different Technical Trades) in PMT Establishment. The case of Electrician ASI Munna Minz of PMT Regional Workshop Rourkela (CSB Sl. No.2) was placed before the CSB on 30.12.2024 for consideration of his promotion to the rank of Sub-Inspector in Fitter Trade. The CSB after scrutinizing the service record of Munna Minz decided to keep his recommendation in a sealed cover in pursuance of Govt. of Odisha G.A. Department Office memorandum No.3928/Gen dtd.18.02.1994 and subsequent amendment to the provision in the above O.M. vide G.A. Deptt. O.M. No.29699/Gen, dtd. 01.11.1997 as Plant site P.S Case No. 410/2022 was pending against him.

After being acquitted vide order dtd. 17.06.2024 of the Hon'ble S.D.J.M, Panposh in Plant site P.S Case No. 410/2022, Electrician ASI Munna Minz submitted a representation dtd. 20.01.2025 for consideration of his promotion to the rank of Sub-Inspector in Fitter Trade.

As per orders of the DGP the sealed cover containing findings of the CSB-2024 held on 30.12.2024 in respect of Electrician ASI Munna Minz of PMT Establishment was opened on 03.07.2025 and found that he has been selected by the CSB for the year-2024 held on 30.12.2024 for promotion to the rank of Sub-Inspector in Fitter Trade.

Having been selected by the CSB,2024 held on 30.12.2024, Electrician ASI Munna Minz of PMT Establishment is allowed retrospective promotion to the rank of Sub-Inspector in Fitter Trade w.e.f. the date his immediate junior Biswaranjan Sardar (ST) (CSB Sl.No.-3) was promoted to the rank of Sub-Inspector (Fitter Trade) as per the results of the CSB held on 30.12.2024.

On promotion the inter-se-seniority of Shri Munna Minz is fixed in the rank of Sub-Inspector (Fitter Trade) above Shri Biswaranjan Sardar who was allowed promotion to the rank of Sub-Inspector (Fitter Trade) vide S.P. Hdqrs. Office Order No.63/Pers.-II, dtd.13.01.2025.

His pay in the rank of Sub-Inspector (Fitter Trade) shall be fixed notionally from the date his immediate junior Biswaranjan Sardar was promoted to the rank of Sub-Inspector in Fitter Trade. His promotional posting will be decided by the Range Police Establishment Board of Signal Establishment.


