OFFICE ORDER NO. 2928 /Pers.-II, DT. 04 /08/2025.

In pursuance to the order dtd.16.01.2025 of the Hon'ble High Court of Orissa passed in W.P. (C) No.30632/2024 filed by Rajkishore Nayak, ASI (Armed) –Vrs.- State of Odisha and others as well as orders of the Govt. thereon to implement the order of the Hon'ble High Court of Orissa, a review CSB was held on 19.07.2025. The said CSB reviewed the selection of CSB-2024 held on 11.09.2024 for promotion of ASI (Armed) to the rank of SI (Armed) in pursuance to SC & ST Development Department letter No.5031/SSD, Dtd.27.02.2025 and selected 58 ASIs of Police (Armed) (Odia Coys) of Battalion Cadre and District Cadre afresh for promotion to the rank of SI of Police (Armed) (Odia Coys). The names of the following 18 ASIs of Police (Armed) (Odia Coys) found place newly in the said review select list-2025 for promotion to the rank of SI of Police (Armed) (Odia Coys).
