OFFICE ORDER NO. 2929 /Pers.-II,

DT. 04 /08/2025

In pursuance to the order dtd.16.01.2025 of the Hon'ble High Court of Orissa passed in W.P. (C) No.30632/2024 filed by Rajkishore Nayak, ASI (Armed) –Vrs.- State of Odisha and others as well as orders of the Govt. thereon to implement the order of the Hon'ble High Court of Orissa, a review CSB was held on 19.07.2025. The said CSB reviewed the selection of CSB-2024 held on 11.09.2024 for promotion of ASI (Armed) (Odia Coys) to the rank of SI (Armed) (Odia Coys) in pursuance to SC & ST Development Department letter No.5031/SSD, Dtd.27.02.2025 and selected 58 ASIs of Police (Armed) (Odia Coys) of Battalion Cadre and District Cadre afresh for promotion to the rank of SI of Police (Armed) (Odia Coys).

In the above review Board, the name of the following ASIs of Police (Armed) (Odia Coys) of General Category who were selected by the CSB-2024 held on 11.09.2024 for promotion to the rank of SI of Police (Armed) vide S.P. Hdqrs. O.Os. No.821/Pers.-II, Dtd.23.09.2024 & No.965/Pers.-II, Dtd.07.11.2024 did not figure in the review select list held on 19.07.2025 for promotion to the rank of SI of Police (Armed). Accordingly, the CSB also decided to cancel their selection for promotion to the rank of SI (Armed) done as per the CSB-2024. The SI (Armed) of Gurkha Coys who were promoted as per CSB-2024 held on 11.09.2024 remains unchanged.
