Having been selected by the Central Selection Board held on 19.08.2025 in pursuance of Govt. of Odisha, Home Department Notification No.11400/D&A dtd 28.02.2009, the following Constables are allowed to officiate as ASI of Police. They will assume higher charge of Officiating ASI of Police from the date of their joining. They will undergo ASI Course of Training comprising of four months of Institutional Training and two months practical training in accordance with Govt. of Odisha Home Deptt. Notification No.3354/D&A dtd 15.10.2020.

The selection is subject to detailed verification of service records on or before the commencement of the training.

As per Section 7(1) of Odisha Police Service (Method of Recruitment and Conditions of Service of Assistant Sub-Inspectors) Order, 2020, the Basic ASI's Course of training shall comprise four months of institutional basic course of training at designated training institutes followed by two months attachment in Police Station for practical training.

The Trainee ASIs are required to pass the final examination of ASIs course of Training which will be held after four months institutional basic course of training.

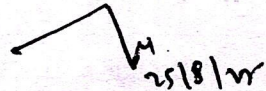
The inter-se-seniority of the candidates for the training to the rank of ASI shall be determined on the basis of marks obtained by them in the final examination of ASI course of Training.

The above-named selected candidates will report their joining as Trainee ASI of Police immediately in **PTC, Angul** for undergoing Basic ASI Course of Training in the batch commenced with effect from 19.08.2025.

Necessary entry to this effect may be made in service book of the concerned Trainee ASI of Police.

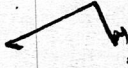
