OFFICE ORDER NO. 89 /Pers.-II dtd. 16.01.2025.

(1) The case of S.I. (Armed) Samit Samal (UR) of OISF, Bhubaneswar (Now in Jagatsinghpur District) (Sl. No.86 of 2023 CSB and Sl. No.08 of 2024 CSB) was taken into consideration by the CSB-2023 & 2024 respectively for his promotion to the rank of Inspector of Police (Armed). The CSB for the year 2023 and 2024, did not select him for promotion to the rank of Inspector of Police (Armed) due to adverse entry in CCR for the period from 01.04.2019 to 31.03.2020 and from 01.04.2020 to 06.01.2021 respectively and major punishment of one "Black Mark" imposed on him vide SOG Prog. No.32/2020.

The above adverse remarks were expunged vide S.P. Hdqrs. memo No.532/ACR Cell, Dtd.20.08.2024 and the above major punishment of "Black Mark" was also reduced to "Warning in SB" by the ADGP (Ops.), Odisha, BBSR vide order dtd.18.10.2023.

Thereafter, on consideration of his representation, it was ordered by the DGP to hold a Spl. CSB to assess his suitability for retrospective promotion to the rank of Inspector of Police (Armed) w.e.f. 2023. Accordingly, he was selected by the Spl. CSB held on 02.01.2025 for his retrospective promotion to the rank of Inspector of Police (Armed) from the year-2023 i.e. from the date his immediate junior was allowed promotion to the rank of Inspector of Police (Armed) vide S.P. Hdqrs. O.O. No.1037/Pers.-II, Dtd.14.07.2023.

(2) Further, the case of S.I. (Armed) Janardan Nayak (SC) of Mayurbhanj District (Now in Balasore District) (Sl. No.131 of 2023 CSB and No.11 of 2024 CSB) was taken into consideration by the CSB-2023 & CSB-2024 for promotion to the rank of Inspector of Police (Armed). The findings of the above CSB in his respect was kept in individual sealed covers in pursuance of G.A Department Office Memorandum No. 3928/Gen., dtd. 18.02.1994 and subsequent amendment made to it, due to pendency of Mayurbhanj District Proceeding No.47/2022 against him. The said proceeding was disposed off and he was exonerated from the charges by the disciplinary authority vide Order Dtd.26.06.2024.

Thereafter, he submitted representation for promotion to the rank of Inspector of Police (Armed) retrospectively. On consideration of his representation and as per the orders of the DGP, the sealed covers containing the recommendation of CSB for the year 2023 & 2024 were opened and it was found that SI (Armed) Janardan Nayak was "Not Selected" by both the CSBs due to his adverse CCR for the period from 18-07-2021 to 31-03-2022. The said adverse remarks was also expunged by the DGP vide S.P. Hdqrs. Memo No.373/ACR Cell, Dtd.31.07.2024 and published vide Balasore district D.O. No.1562, Dtd.13.08.2024.

Then, it was once again put up before the DGP for consideration of his promotion to the rank of Inspector of Police (Armed) retrospectively w.e.f. the year-2023 and as per the orders of the DGP, a Spl. CSB was held on 02.01.2025 to adjudge his suitability for promotion to the rank of Inspector of Police (Armed) retrospectively from the year-2023. Accordingly, the Spl. CSB found him suitable for promotion to the rank of Inspector of Police (Armed) retrospectively from the year-2023 i.e. from the date his immediate junior was allowed promotion to the rank of Inspector of Police (Armed) vide S.P. Hdqrs. O.O. No.1037/Pers.-II, Dtd.14.07.2023.

Having been selected by the Special Central Selection Board (CSB) held on 02.01.2025 for selection of the following 02 Sub-Inspector of Police (Armed) for promotion to the rank of Inspector of Police (Armed) retrospectively with effect from the date of their juniors have been promoted to the rank of Inspector of Police (Armed) as per recommendation of the CSB for the year-2023 held on 07.07.2023.

Their inter-se-seniority in the rank of Inspector of Police (Armed) on such retrospective promotion is fixed as per Column No. D as mentioned below.


They will be paid the actual financial benefit in the rank of Inspector of Police (Armed) from the date they join the promotional post of Inspector of Police (Armed).


