The case of Ex.S.I. Padmalochan Panigrahi (CSB Sl.No.147 of 2021) held on 08.02.2021 of Mayurbhanj district (now Inspector of Police in Police Commissionerate) for promotion to the rank of Inspector of Police, but the findings of the CSB regarding his promotion was kept in a sealed cover due to pendency of Balasore district Proceeding No.08/2014 against him. In the meantime, Balasore district Proceeding No. 08/2014 has been disposed of vide Balasore D.O.No.287 dtd 01.02.2023 by exonerating him from all the charges levelled against him.

After disposal of the above proceeding, Ex.S.I. Padmalochan Panigrahi has submitted a representation on dtd 11.05.2024 for consideration of his retrospective promotion to the rank of Inspector of Police from the year 2021. The matter was examined at S.P.Hdqs. and placed before the DGP.


As per the orders of the DGP, the sealed cover containing the findings of the CSB for the year 2021 held on 08.02.2021 in respect of Ex. S.I. Padmalochan Panigrahi was opened on 09.10.2024 and found that he has been selected by the CSB for the year 2021 held on 08.02.2021 vide CSB Sl. No.147 of 2021.

Having been selected by the CSB 2021 held on 08.02.2021, Ex.S.I. Padmalochan Panigrahi is allowed promotion to the rank of Inspector of Police retrospectively with effect from the date his immediate junior Ex. S.I. Ganesh Prasad Mallik of Spl. Branch (now retired as Inspector of Police in Spl.Branch) (CSB Sl. No.148 of 2021) was allowed promotion to the rank of Inspector of Police vide State Police Hdqs. Office Order No. 337/Pers.I dtd 29.04.2021. Accordingly, his seniority in the rank of Inspector of Police is fixed above Ex. S.I. Ganesh Prasad Mallik now Inspector of Police(retired) and below Inspector Durgesh Nandini Mohanty (CSB Sl. No.145) of Police Commissionerate.

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher-grade post.


