OFFICE ORDER No. 950 /Pers-I, Dated 04 .11.2024

The case of S.I. Sambit Kumar Swain (CSB Sl.No.126) of Koraput district was placed before the Spl. CSB for the year 2021 held on 27.05.2022 for promotion to the rank of Inspector of Police, but the findings of the CSB regarding his promotion was kept in a sealed cover due to pendency of Rayagada district Proceeding No.09/2016 against him. In the meantime, Rayagada district Proceeding No. 09/2016 has been disposed of by awarding him one minor punishment i.e. "Censure in SB" vide Rayagada D.O.No.895 dtd 20.05.2024.

After disposal of the above proceeding, SI Sambit Kumar Swain has submitted a representation on dtd 23.08.2024 for consideration of his retrospective promotion to the rank of Inspector of Police against Spl. CSB-2021. The matter was examined at State Police Hdqrs. and placed before the DGP.

As per the orders of the DGP, the sealed cover containing the findings of the Spl. CSB for the year 2021 held on 27.05.2022 in respect of S.I. Sambit Kumar Swain of Koraput district was opened on 28.10.2024 and found that he has been selected by the Spl. CSB for promotion to the rank of Inspector of Police.


Having been selected by the Spl. CSB for the year 2021 held on 27.05.2022, S.I. Sambit Kumar Swain of Koraput district is allowed promotion to the rank of Inspector of Police retrospectively with effect from the date his immediate junior Ex. S.I. Ranitarani Pradhan of Angul district now Inspector of Police in Kalahandi district (CSB Sl. No.127) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 561/Pers.I dtd 06.06.2022. Accordingly, his seniority in the rank of Inspector of Police is fixed above Ex. S.I. Ranitarani Pradhan now Inspector of Police.

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher-grade post.

His promotional posting will be decided by the Police Establishment Board.
