The case of Sri Manoj Kumar Behera, Ex.Senior Clerk (now Head Clerk of DPO, Bargarh) was placed before the Departmental Promotion Committee held during the year,2011,2012, 2016, 2018, 2019, 2020 & 2021 for consideration of his promotion to the rank of Head Clerk. The findings of the DPC in respect of Sri Behera was kept in individual sealed cover due to pendency of Criminal Case i.e UPD Cuttack Mahila PS Case No.67, dtd.10.11.2009 u/s 498(A)/506/34 IPC/4 DP Act. corresponding to GR Case No.1379 of 2009 in pursuance of G.A. Department Office Memorandum No.3928/Gen., dtd.18.02.1994. The said case was disposed of vide judgement dtd. 27.06.2022 by the Hon'ble JMFC, Cuttack in which Sri Behera has been declared not guilty of the charges leveled against him in the above noted offences and thereby acquitted u/s 248 (1) of Cr. P.C..

Thereafter, basing on the representation of Sri Behera, Senior Clerk of DPO, Bargarh for his retrospective promotion, DGP, Odisha was pleased to pass order for opening of the sealed covers in pursuance to the G.A. Department Office Memorandum No.3928/Gen., dtd.18.02.1994. Accordingly, the sealed covers was opened on 20.12.2024 and found that Sri Behera was not selected by the DPC, 2011 and selected by the DPC, 2012, 2016, 2018, 2019, 2020 & 2021 for promotion to the rank of Head Clerk. Hence, Sri Behera is entitled to get retrospective promotion to the rank of Head Clerk from the DPC, 2012.

Having been selected by the Departmental Promotion Committee held on 07.06.2012, Sri Manoj Kumar Behera, Ex.Senior Clerk (now Head Clerk of DPO, Bargarh) is promoted to the rank of Head Clerk retrospectively with effect from the date his junior P.C.Chyau Pattnaik, Ex. Sr.Clerk got promotion to the rank of Head Clerk vide State Police Hdqrs., Cuttack Office Order No.929/Min., dtd. 20.06.2012.

The pay of Sri Behera will be fixed notionally in the time scale of higher grade with effect from the date his junior Sri Pattnaik got promotion to the rank of Head Clerk. He will not be eligible for any arrear financial benefits for the period he has not actually worked in the higher post/grade.

This issues with the approval of DGP.
