Their appointment order will be issued by their respective Appointing Authorities (i.e. Heads of Police Districts or Establishments) immediately.

Their appointment on regular basis will be provisional subject to satisfactory verification of the following documents:-

(a) Character & Antecedents reports.

(b) Medical fitness certificate duly issued by the authorized Government Doctor.

(c) Original certificates of his/her eligibility for the post which shall include certificates of age, caste or category, Educational qualifications.

(d) Discharge certificate in respect of Ex. Servicemen from concerned issuing/ competent authority.

(e) Confirmation of genuineness of PWD candidates of their disability from the Appellate Medical Board as per provision under clause-2(3) of the Department of SSEPD, Odisha Resolution No.1843/SSEPD, dtd.25.02.2021 by the respective Appointing Authority observing due procedure.

In case, any information/certificates submitted by the candidates is established to be false or incorrect at any stage, their services will be terminated forthwith in accordance with the provisions laid down vide clause (h) of explanation under Rule-13 of Orissa Civil Service (Classification, Control and Appeal) Rules, 1962.

Their appointment is purely temporary and can be terminated at any time without notice assigning any reason thereof. They shall be on probation for a period of two years which shall be counted from the date of joining the post.

The Appointing Authority shall have to incorporate all the terms and conditions in pursuance to the Odisha District Police Ministerial Service (Method of recruitment and conditions of service) working under the Districts Police Offices Rules-2021 and amendment Rules-2022 notified vide Home Department Notification No.38061/D&A, dtd.29.10.2021 and Notification No.35401/D&A, Dtd.14.10.2022 and subsequent amendments there on while issuing appointment order to the selected candidates at their level.
