In pursuance of Odisha Staff Selection Commission Notification Nos. 2855/Ossc dt. 6.9.2012, No. 808/OSSC dt. 23.3.2013, No.846/OSSC dt. 2.4.2013 and in continuation of State Police Hdqrs. Office Order No.1595/Exe dt.8.9.12, the following selected candidates are appointed temporarily as Cadet Sub-Inspectors of Police in the Pay Band of Rs.9300-34800/- with Grade Pay-4200/- with usual D.A. with effect from the date of their joining for undergoing S.I's course of training at Biju Pattnaik State Police Academy, Bhubaneswar as per Rule 28 of Government in Home Department Resolution No. 22543/D&A dt.27.5.2006 regulating the "Odisha Police Service (Condition of Service and Method of Recruitment of Sub-Inspectors) Order, 2006". Their appointment is subject to submission and re-verification of original certificate of age, caste/ category, educational qualification and wherever required Ex.Service-man certificate and Sports certificate issued by the competent authority and their medical fitness certificate issued by an authorized Government Doctor and subject to verification of character and antecedents. Their appointment is purely temporary and can be terminated at any time without assigning any reason thereof. However, their appointment is subject to the result of the W.P(C) No. 17753 of 2012 pending before the Hon'ble High Court of Odisha, Cuttack.

The selected candidates appointed as S.I. of Police will undergo S.I.'s course of training for a period of one year at Biju Pattnaik State Police Academy, Bhubaneswar.

They should execute a bond in P.M. Form No.106-A on their joining at Biju Pattnaik State Police Academy, Bhubaneswar.

They are liable to be discharged at any stage of their training career if their progress in monthly or periodical examination is found unsatisfactory or they otherwise render themselves undesirable.

They should be fit to attend parade and physical lessons throughout the year. Any report from a Doctor declaring any of the appointees unfit to undergo lessons for any length of time will make him liable for discharge from service.

Their inter-se-seniority in the rank of S.I of Police will be determined as per Home Deptt. Resolution No. 22706/D&A dt. 18.5.2010.

After his reporting at Biju Pattnaik State Police Academy, Bhubaneswar, his physical and medical fitness shall be checked by the Medical Officer of BPSPA, BBSR, who will issue him Medical Fitness Certificate before acceptance of his joining.


3.(a) He/ She will be supplied approved uniform on joining at Biju Pattnaik State Police Academy, Bhubaneswar. Besides he/she should however bring with him/her the following items of civvies. They can also purchase these items at Bhubaneswar.

FOR MALE CANDIDATES.

1. Two pairs of formal trousers.
2. Full shirt, half shirt (formal).
3. Full shoes (formal) with socks.
4. Sports shoes (white) & white socks.
5. Tie.

FOR WOMEN CANDIDATES.

1. Formal Sarees/ Salwar Kameej.
 2. Sports shoes (white) & white socks.
- (b) Each may bring a box not exceeding the size of 3' X 2' X 1 ½ , Mosquito net/ blanket, bed holder etc. for their use.
- (c) Each cadet Officer will be provided with two pairs of P.T. Uniform (white T. Shirt and Track lower) at the Academy on payment. Approximate cost may be of ₹ 1,000/- (one thousand only).
4. Books and reading materials:
Study materials and Law Books will be supplied on payment to the trainees on arrival at the Academy. The cost of the study materials may come approximately to ₹ 3000/- (Three thousand) only.
5. Deposit of Advances at the time of reporting:
Each trainee shall have to deposit ₹ 9,000/- (Nine thousand) only in total towards (cost of books- ₹ 3000/-, Messing advance- ₹ 5,000/-, P.T. Uniform – ₹ 1,000/-) with the Cashier of BPSPA.
6. Laundry:
The laundry has been outsourced to a reputed firm for mechile washing and stream ironing. The charges are ₹ 200/- per month for washing 40 garments.
7. Medical Fitness Certificate.
On arrival the trainee shall appear before the Medical Officer (M.O) of BPSPA and get themselves medically examined. The M.O will issue a certificate indicating the fitness to undergo the physical training.
8. Leave: During the period of training, no leave will ordinarily be granted to the trainees, except in urgency.
9. He/ She should submit the supporting original documents in respect of their age, Caste/ category, educational qualifications, Ex. Serviceman certificate, Sports certificate issued by the competent authority to the Director, BPSPA Odisha, Bhubaneswar for re-verification. Director, BPSPA Odisha, Bhubaneswar to please point out discrepancies if any to this Hdqrs. immediately for further follow up action.
