

HOME-SPS-CASE1-0160-2021- 31392 /SPS, Shri Geeti Ranjan Mohapatra, Inspector of Police is hereby promoted retrospectively on ad-hoc basis to the grade of OPS Group-A (Junior Branch) i.e. Deputy Superintendent of Police of the O.P.S.
