- 1. The Odisha Police –Odisha Police (Tender Inviting Authority) is a Govt. organization working under Home Department, Govt. of Odisha.
- 2. The bid documents published by the Bid Inviting Officer (Procurement OfficerPublisher) in the eprocurement portal https://tendersodisha.gov.in will appear in the "Latest Active Tender". The Bidders/ Guest Users can download the Bid documents from 11/02/2025 and submit it online on 20/02/2025, 05.00 PM after which the same will be removed from the list of "Latest Active Tender".

4.1 PARTICIPATION IN BID

4.1.1 PORTAL REGISTRATION:

The bidder intending to participate in the bid is required to register in the e- procurement portal using an active personal/official e-mail ID as his/her Login ID and attach his/her valid Digital signature certificate (DSC) - Class II or III to his/her unique Login ID. He/ She has to submit the relevant information as asked for about the bidder. The portal registration of the bidder is to be authenticated by the State Procurement Cell after verification of original valid certificates/documents such as (i) PAN and (ii) Registration Certificate (RC) / GST Certificate (for Procurement of Goods) of the concerned bidder. The time period of validity in the portal is co terminus with validity of RC/ GST. Any change of information by the bidder is to be re-authenticated by the State Procurement Cell. After successful authentication, bidder can participate in the online bidding process.

4.1.2 LOGGING TO THE PORTAL:

The Bidder is required to type his/her Login ID and password. The system will again ask to select the DSC and confirm it with the password of DSC as a second stage authentication. For each login, a user's DSC will be validated against its date of validity and also against the Certificate Revocation List (CRL) of respective CAs stored in system database. The system checks the unique Login ID, password and DSC combination and authenticates the login process for use of portal.

4.1.3 DOWNLOADING OF BID:

The bidder can download the bid of his / her choice and undertake the necessary preparatory work off-line and upload the completed bid before the closing date and time of submission.

The primary objective for procuring Automatic Forensic Sperm Detection System (Automated Slide Scanner for Sperm Detection System for a Motorized Upright Fluorescence Microscope) for Odisha Police is to enhance the efficiency, accuracy, and reliability of forensic investigations related to sexual assault cases and must be able to serve following objectives:

i. Automated & Rapid Sperm Detection – Reducing manual effort and increasing detection speed.

ii. **High Accuracy & Sensitivity** – Ensuring precise identification of sperm cells for forensic evidence.

- iii. Improved Case Turnaround Time Enhancing efficiency in forensic labs for faster case resolution.
- iv. Standardized & Reliable Analysis Minimizing human error and ensuring reproducibility of results.
- v. Compliance with Forensic Standards Adhering to national and international forensic guidelines.

7. Scope of Work:

The primary reason to procure a Automatic Forensic Sperm Detection System integrated with a Motorized Upright Fluorescence Microscope for the Odisha Police Department is to enhance forensic analysis efficiency, improve the accuracy of sperm detection in sexual assault cases, and reduce case processing times. It will support standardized forensic procedures and ensure compliance with legal and scientific standards, thereby strengthening criminal justice outcomes. 13. Conflict of Interest

Conflict of interest exists in the event of conflicting assignments, typically monitoring and evaluation of the mandate being executed by the selected bidder in the future.

14. Anti-corruption Measure
