3. Instruction to the Bidders

- 1. The Odisha Police –Odisha Police (Tender Inviting Authority) is a Govt. organization working under Home Department, Govt. of Odisha.
- 2. The bid documents published by the Bid Inviting Officer (Procurement OfficerPublisher) in the e-procurement portal https://tendersodisha.gov.in will appear in the "Latest Active Tender". The Bidders/ Guest Users can download the Bid documents from 24/03/2025 and submit it online by 09/04/2024 4.00 PM after which the same will be removed after which the same will be removed from the list of "Latest Active Tender".

3.1 PARTICIPATION IN BID

3.1.1 PORTAL REGISTRATION:

The bidder intending to participate in the bid is required to register in the e- procurement portal using an active personal/official e-mail ID as his/her Login ID and attach his/her valid Digital signature certificate (DSC) - Class II or III to his/her unique Login ID. He/ She has to submit the relevant information as asked for about the bidder. The portal registration of the bidder is to be authenticated by the State Procurement Cell after verification of original valid certificates/documents such as (i) PAN and (ii) Registration Certificate (RC) / GST Certificate (for Procurement of Goods) of the concerned bidder. The time period of validity in the portal is co terminus with validity of RC/ GST. Any change of information by the bidder is to be re-authenticated by the State Procurement Cell. After successful authentication, bidder can participate in the online bidding process.

3.1.2 LOGGING TO THE PORTAL:

The Bidder is required to type his/her Login ID and password. The system will again ask to select the DSC and confirm it with the password of DSC as a second stage authentication. For each login, a user's DSC will be validated against its date of validity and also against the Certificate Revocation List (CRL) of respective CAs stored in system database. The system checks the unique Login ID, password and DSC combination and authenticates the login process for use of portal.

3.1.3 DOWNLOADING OF BID:

The bidder can download the bid of his / her choice and undertake the necessary preparatory work off-line and upload the completed bid before the closing date and time of submission.

3.1.4 CLARIFICATION OF BID:

- 4.1.5 *User Institutions* are the Odisha Police under Home Department, Govt. of Odisha for which the items under this bid is procured.

The primary objective of procuring Video authentication software for the Odisha Police as Video authentication software systems are becoming increasingly important for police departments in India for several reasons:

- i. **Evidence Integrity:** Video authentication software ensures that digital evidence, such as footage from surveillance cameras, body-worn cameras, or mobile phones, remains unaltered and tamper-proof. This is crucial for maintaining the integrity of evidence presented in court.
- ii. **Verification of Authenticity:** The software can validate whether a video has been manipulated or altered, ensuring the reliability of evidence. It can detect any edits or inconsistencies in the footage, which is important for legal and investigative purposes.
- iii. **Crime Investigation:** Forensic analysis of video evidence helps investigators establish timelines, identify suspects, and reconstruct crime scenes. Authentication software provides a layer of trust in the digital material used in these investigations.
- iv. **Accountability and Transparency:** In incidents involving police personnel, such as the use of force or high-stakes operations, video authentication can promote accountability by providing unaltered records of events, improving public trust.
- v. **Combating Misinformation**: With the increasing spread of fake or altered videos, police departments can use authentication tools to quickly verify the authenticity of videos, helping to prevent the spread of misinformation and panic.

vi. **Legal Compliance:** Courtsoften require authenticated video evidence to ensure the fair administration of justice. Video authentication software helps police meet these legal standards.
