

YOU ARE ONCE AGAIN DIRECTED TO COLLECT INTELLIGENCE ABOUT ILLEGAL MANUFACTURE AND SALE OF FIREWORKS AND CRACKERS AND ENSURE THAT STRINGENT LEGAL ACTION IS TAKEN AGAINST THE PERSONS RUNNING SUCH UNITS IN YOUR JURISDICTION (.)
