The terms and conditions of their service will be issued by the Appointing Authorities in pursuance to Home Department Notification No.2539 (M)/Home-DAT- Rule-0194-2014 dtd.03.02.2015 and their respective recruitment/ cadre rules.

If, at any time after appointment of a meritorious sportsperson under these rules, the particular sporting achievement for which the sportsperson gets appointment is declared as void or derecognized by the competent National or International Sporting Association for the sportsperson failing in dope test or for any other reason, the service of the sportsperson concerned shall be terminated after considering his/ her show cause reply on merit and giving him/her reasonable opportunity to defend his/her case.

The category as against each of the above selected candidates may be entered in their service books and they will be counted against their respective category for all purpose.
