No.34701-HOME-DAI-RULE-0001/2021/D&A.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Odisha do hereby make the following Rule further to amend the Odisha District Police Ministerial Service (Method of Recruitment and Conditions of Service) working under the District Police Offices Rules, 2021, namely:-

1. Short title and commencement.- (1) These rules may be called the Odisha District Police Ministerial Service (Method of Recruitment and Conditions of Service) working under the District Police Offices Amendment Rules, 2022.

(2) They shall come into force on the date of their publication in the Odisha Gazette.

2. In the Odisha District Police Ministerial Service (Method of Recruitment and Conditions of Service) working under the District Police Offices Rules, 2021, in rule 2, in sub-rule (1), after clause (a), the following clause shall be inserted, namely:-

"(aa) "Appointing Authority" means,-

(i) The Heads of Police Districts or Establishments in respect of Junior Clerk;

(ii) The Range Authorities in respect of Senior Clerk & Head Clerk; and

(iii) The Director General of Police in respect of Office Superintendents."
