

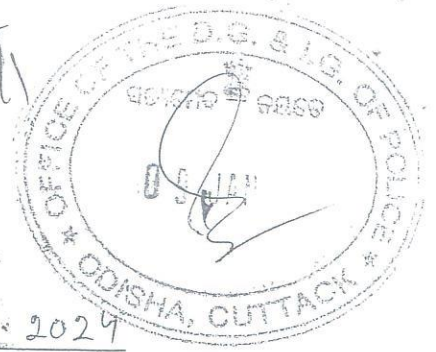

**Sub: Special Leave in respect of retired Government Servants re-engaged as per G.A. Department Resolution No.23750/Gen dt.27.08.2014.**

At present, re-engagement of retired Government Servants is being governed in accordance with the comprehensive guidelines issued by General Administration Department in Resolution No.23750/Gen dated 27.08.2014. The question of extending the Special Leave benefit in case of retired employees on re-engagement, has been under active consideration of Government.

2. The benefit of Special Leave for 12 days at the maximum (subject to exigencies of public service) during the period of engagement of one year in case of persons engaged on contractual basis in different Departments, has been provided according to Finance Department O.M. No.30794 dated.06.11.2021.

3. After careful consideration, Government have been pleased to extend the same benefit i.e. Special Leave of 12 days at the maximum (subject to exigencies of public service) during the period of engagement for one year in respect of retired Government Servants who are re-engaged as per General Administration Department Resolution No.23750/Gen dt.27.08.2014.

4. Suitable clause for provision of the Special Leave benefit of 12 days per year shall be inserted in the requisite agreement on re-engagement during post-retirement period.

This shall take effect from the date of issue.
