Sir,

In inviting a reference to the subject cited above, I am directed to say that with a view to redress genuine hardship faced by the deductors of the state of Odisha due to the severe disruption caused by cyclone "Fani", the Central Board of Direct Taxes, Ministry of Finance, Government of India in exercise of its powers under section 119 of the Income Tax Act, 1961 has extended the due date of filing of Quarterly Statement of TDS for the last quarter of financial year 2018-19 from 31st May, 2019 to 30th June, 2019. Similarly, the due date for issue of TDS certificate in Form 16 and 16A has been extended from 15th June, 2019 to 15th July, 2019. The copy of the letter No. F. No.275/38/2017-IT (B), dated 24th May, 2019 received from CBDT in this regard is enclosed herewith for kind reference.

The same may kindly be brought to the notice of all the Controlling Officers and Drawing & Disbursing Officers/tax deductors (from salary) under your control with instructions to adhere to the revised due date for the purpose of filing of Quarterly Statement of TDS and issuing TDS certificates.
