Sub- Submission of Property Statement by Government Servants (Gazetted and Non-Gazetted)- Instructions regarding.

As per principles outlined under Rule-21 of the Odisha Government Servants' Conduct Rules, 1959, and time to time instructions issued by G.A. Department circulars ending with circulars letter No.3244/Gen dated 06.02.2016, every Government Servant is required to make a true and complete declaration of all his assets, movable and immovable, and the value thereof as on the 31st March every year in the form given in Appendix-A on or before 31st July of that year.

It has been brought to the notice of all concerned in this Department Circular Letter No. 7202 dated 5.4.2017 to furnish the property statement for the ensuing period 01.04.2016 to 31.3.2017 through online using HRMS in due time without fail.

Now, it has come to the notice that, many of the Government employees have not been able to submit their property statement in due time as they are not conversant with submission of property statement through online using HRMS.

It is, therefore, brought to the notice of all concerned that, the period of submission of property statement through online using HRMS for the ensuing period 01.04.2016 to 31.3.2017 is hereby extended up to 30.9.2017.
